



CALL FOR APPLICATIONS FOR THE SELECTION OF CONTRACT STAFF

No CA.2016.01 — Scientific agent Contract Agent (M/F) FG III — Five-year contract

The EMCDDA is one of the European Union's decentralised agencies. Established in 1993 and based in Lisbon, it is the central source of comprehensive information on drugs and drug addiction in Europe.

The EMCDDA is an equal opportunities employer and accepts applications without distinction on the grounds of age, race, political, philosophical or religious conviction, gender or sexual orientation and regardless of disabilities, marital status or family situation. 1. Job profile

1.1. Overall purpose

The jobholder will work as a scientific assistant in the Estimates, statistics and data management sector, located within the Prevalence, data management and content coordination unit (EPI). The main focus of the work will be the preparation and analysis of data sets required for the European Drug Report and other EMCDDA products. In general, working closely with the EPI analytical team, other units and data providers, and under the coordination of the Head of Estimates, statistics and data management sector, the jobholder will provide data management and statistical support for the work necessary to monitor and report on the drug situation in Europe.

The jobholder will be involved in managing the validation, processing, analysis and reporting of data collected by the EMCDDA. The main data collection procedures relate to aggregated data, which is collected from the Member States using a bespoke data collection programme called Fonte. Additional *ad hoc* collections are undertaken which may include case-level data and may be completed in a range of formats.

Considering the horizontal nature of the contacts the job holder will have with all other EMCDDA units and external partners, and in order to ensure efficient execution of tasks, the vehicular language for this post has been defined as English.

1.2. Main duties

The successful applicant will be requested to contribute to the following tasks:

- Manage and validate data collected by the EMCDDA on the drug situation in Europe.
 This is undertaken in close collaboration with the Member States and other institutions providing the data;
- Construct and revise data tables and graphs, paying particular attention to data anomalies:
- Document all data extraction processes and data anomalies;



- Review chapters from the annual national workbooks on drug-related issues, cross checking the enclosed information against data submitted through Fonte and extracting any additional information into usable series;
- Provide basic statistical support when appropriate;
- Produce tables and graphs for the EMCDDA products;
- Support the work of project managers, including the preparation for annual expert meetings;
- Any other tasks on request of the Head of the Estimates, statistics and data management sector and/or the Head of the EPI unit.

2. Job requirements

2.1. Eligibility requirements

The following requirements shall be met by the deadline for applications:

· A post-secondary education attested by a diploma,

OR

- a secondary education attested by a diploma giving access to post-secondary education and appropriate professional experience of three years;
- At least three years of relevant professional experience starting with the first position occupied after the completion of the diploma required for admission to this selection procedure, as mentioned above;
- Be a national of one of the Member States of the European Union, Norway or Turkey;
- Have fulfilled any obligations imposed by the applicable laws concerning military service;
- Produce the appropriate character references as to suitability for performance of the required duties;
- Be physically fit to perform his/her duties; and
- Have a thorough knowledge of English and a satisfactory knowledge of another EU language to the extent necessary for the performance of the required duties.

2.2. Essential requirements

Eligible candidates will then be evaluated as follows:

A. On the basis of the paper application by assessing the following:

- Proven ability to extract the essential elements from information collected from
 multiple sources and to prepare summaries and/or short reports on the basis of that
 information (three samples to be provided by e-mail: <u>AC.2016.01@emcdda.europa.eu</u>);
- Proven ability to use planning, monitoring and reporting instruments, including Excel spreadsheets;
- Excellent analytical and organisational skills with a service- and project-oriented approach to be documented in the application in the area devoted to work experience;
- Proven ability to communicate effectively in English in writing and to present complex matters in a simple way.

⁽¹⁾ As a condition for appointment, the successful candidate shall be medically examined in order that the EMCDDA may be satisfied that she/he fulfils this requirement, as foreseen in Article 12(d) of the Conditions of employment of other servants of the European Communities.

- B. On the basis of an interview and written tests by assessing the following:
 - Capacity to manage, clean and validate data and to produce and manipulate graphics and tables;
 - A thorough knowledge of the main MS Office Software, namely Word, Excel, PowerPoint, as well as Internet and e-mail-related applications;
 - Ability to communicate efficiently with people at various levels of seniority, both inside and outside the EMCDDA;
 - A good command of written and spoken English.

2.3. Advantageous requirements

Non-compliance with the advantageous requirements is not a condition for exclusion of applicants as these will be taken into account as assets while assessing each application. Advantageous requirements will only be assessed once during the course of the selection procedure, either in its first or second phase, according to the skills concerned. The advantageous requirements are as follows:

A. On the basis of the paper application by assessing the following:

- A good understanding of social sciences, public health or drug issues and methods;
- Basic understanding of statistical issues;
- Familiarity with one statistical package
- Experience of the preparation of web-based materials;
- Experience of collaboration with analysts and researchers especially from social sciences;
- Knowledge of SQL, MS-Access or other database products.

B. On the basis of the interview and the written tests by assessing the following:

- Good knowledge of the functioning of the European Union institutions, and, in particular, of the role of the EMCDDA;
- Further linguistic skills.

3. Submission of applications

Interested candidates must apply for this post through the EMCDDA e-recruitment application, accessible on this link: https://e-recruitment.emcdda.europa.eu. Please note that to make an EMCDDA online application you will need to create your EMCDDA profile using a valid e-mail address and a password.

The closing date for the submission of applications is 8 February 2016 at 23.59, Lisbon time.

Prior to contract signature the successful candidate will be asked to provide original or certified copies proving her/his eligibility.

4. Selection procedure

The selection will be carried out in two phases:

(1) In the first phase, the selection committee will analyse applications to verify the eligibility of the candidates and assess their compliance with the requirements specified in this call for applications. Failure to comply with one of the eligibility requirements (set out in 2.1. above) shall result in the exclusion of the applicant concerned from the selection procedure.

On this basis, the selection committee will select the candidates that obtain at least 60 % of the total points available to rank their compliance with the essential requirements (set out in 2.2.A. above) out of a maximum of 10 points each, and with the advantageous requirements (set out in 2.3.A. above) out of a maximum of 5 points each. The maximum number of invitees for an interview shall be 10. This ceiling may be adapted, depending on the number of applications received, by decision of the appointing/contracting authority.

(2) The second phase will consist of an interview and a written test. Interviews will be held by the selection committee. The candidates will be assessed on the basis of the essential requirements mentioned above (under 2.2.B) out of a maximum of 10 points each and the advantageous requirements (set out in 2.3.B above) out of a maximum of 5 points each. Candidates will be asked to undergo a written test related to the European integration and institutions, the EMCDDA, as well as the nature of duties to be performed. This will be assessed out of a maximum of 30 points.

The final assessment will be based on the results of the written test and the interview, as indicated under 2.2 and 2.3 above.

Please note that the selection committee's work and deliberations are strictly confidential and that any contact, either direct or indirect, with its members is strictly forbidden. The confidentiality principle is intrinsic to all steps of the recruitment procedure and is in accordance with Article 6 of Annex III to the Staff Regulations of Officials of the European Communities.

Due to the large volume of applications, only candidates selected for the second phase will be contacted. Candidates who have not been contacted by the EMCDDA by 30/04/2016 should consider that their application has been unsuccessful. Applicants invited for the second phase may be entitled to a flat-rate contribution towards travelling and subsistence expenses. Information will be provided together with the invitation letter.

5. Reserve list and engagement

The work of the selection committee ends with the preparation of a draft reserve list of candidates considered suitable to occupy the position advertised, to be proposed to and approved by the appointing/contracting authority of the EMCDDA.

Only candidates who reach 70 % of the marking points available for the second phase can be included in the reserve list for appointment. On the basis of the adopted reserve list, the appointing/contracting authority of the EMCDDA may offer a contract of engagement. Candidates shall note that the inclusion in the reserve list does not guarantee that

recruitment, which will depend, among other things, on availability of vacant posts and budget.



The established reserve list may be used in order to fill similar positions within the EMCDDA.

The reserve list will be valid until 31/12/2018 and may be extended by decision of the EMCDDA appointing/contracting authority.

6. Conditions of employment

6.1. Legal framework

A contract offer will be made pursuant to Article 3(a) of the Conditions of employment of other servants of the European Communities, (see http://eur-lex.europa.eu/ LexUriServ/LexUriServ.do?uri=CONSLEG:1962R0031:20140101:EN:PDF)), for a five-year period according to Article 85 of the aforementioned rules.

The place of employment will be Lisbon, Portugal, where the EMCDDA has its seat.

6.2. Pay and welfare benefits

The jobholder's monthly basic salary for FG III in grade 8 will be approximately EUR 2 400, in grade 9 will be approximately EUR 2 700 and in grade 10 will be approximately EUR 3 100. In addition to this basic salary the job holder may be entitled to various allowances, in particular an expatriation or foreign residence allowance and family allowances, including household allowance, dependent child allowance, pre-school allowance and an education allowance.

Under certain circumstances, in particular where the job holder is obliged to change his/her place of residence in order to take up employment, the EMCDDA may also reimburse various expenses incurred on recruitment, notably removal expenses.

The salary of the job holder is subject to a Community tax deducted at source and is exempt from national tax. The salary package will be affected by a weighting factor and includes the European Community social security and pension schemes.

6.3. Confirmation of engagement and security clearance

Staff engaged by the EMCDDA is required to serve a probationary period of nine months. Successful applicants may be required to undergo a security vetting and clearance procedure.

6.4. Declaration of commitment to serve public interest independently

Staff engaged by the EMCDDA is required to make a declaration of commitment to act independently in the public interest and to make a declaration in relation to the interests that might be considered prejudicial to her/his independence.

EMCDDA staff is required to carry out their duties and conduct solely with the interests of the EMCDDA and of the European Community in mind; they shall neither seek nor take instruction from any government, authority, organisation or person outside her/his institution. EMCDDA staff shall carry out the duties assigned objectively, impartially and in keeping with the duty of loyalty to the EMCDDA and to the European Community.

7. Request for review and appeal procedure

A candidate who feels that a mistake has been made during the selection procedure may ask to have her/his application reconsidered by sending, within 20 calendar days from

The selection committee will reconsider the application and notify the candidate of its decision within 45 calendar days of receipt of the letter.

If a candidate considers that she/he has been adversely affected by a particular decision, she/he can lodge a complaint under Article 90(2) of the Staff Regulations of Officials of the European Communities and Conditions of employment of other servants of the European Communities, at the following address:

The complaint must be lodged within three months. The time limit for initiating this type of procedure (see Staff Regulations http://eur-lex.europa.eu/LexUriServ.do?uri = CONSLEG:1962R0031:20140101:EN:PDF) starts to run from the time the candidate is notified of the act adversely affecting her/him.
